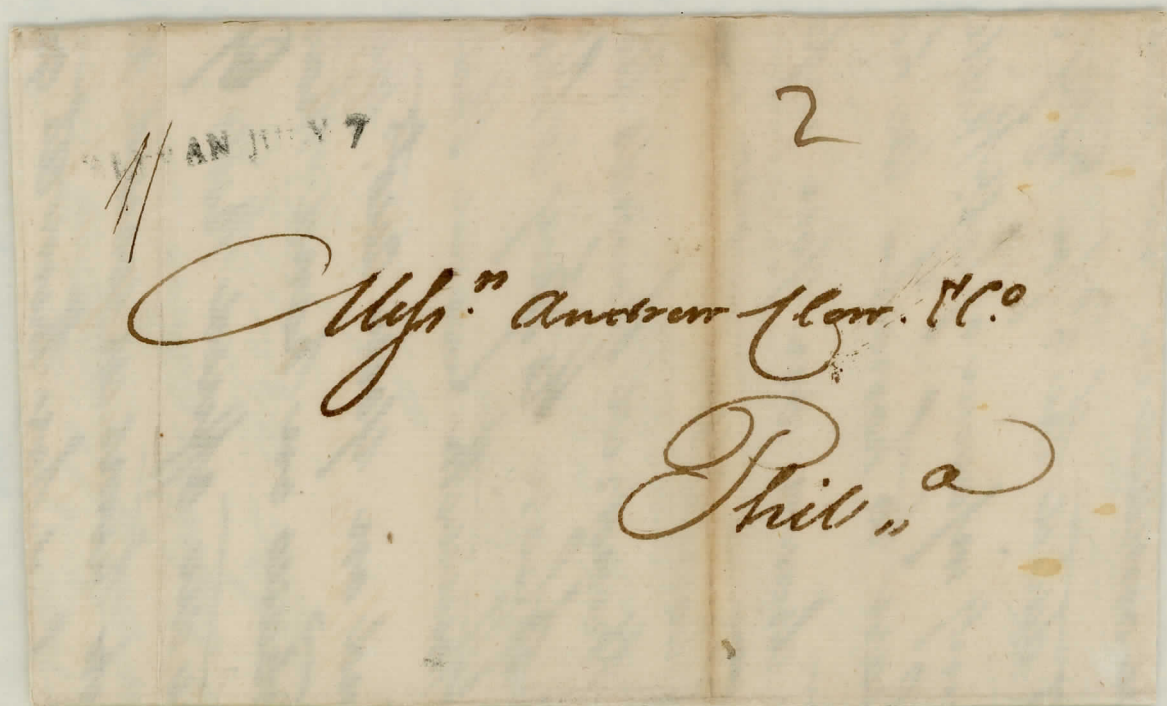

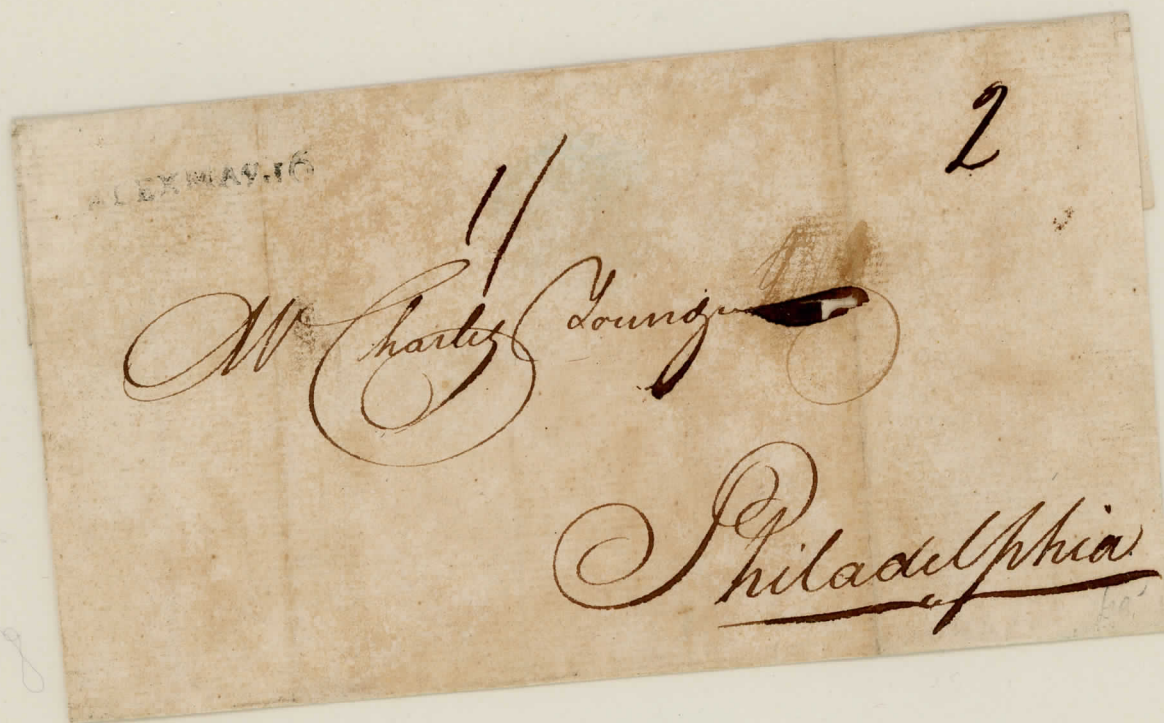
STRAIGHT LINE ALEXAN. JULY 7

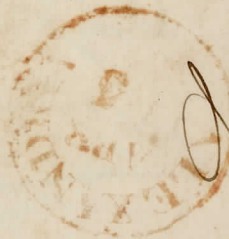

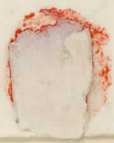
