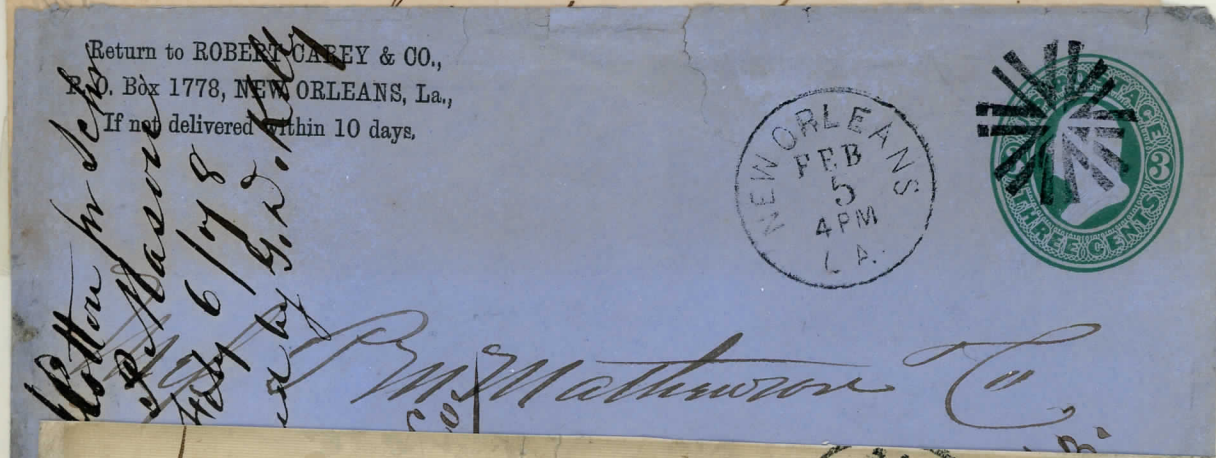
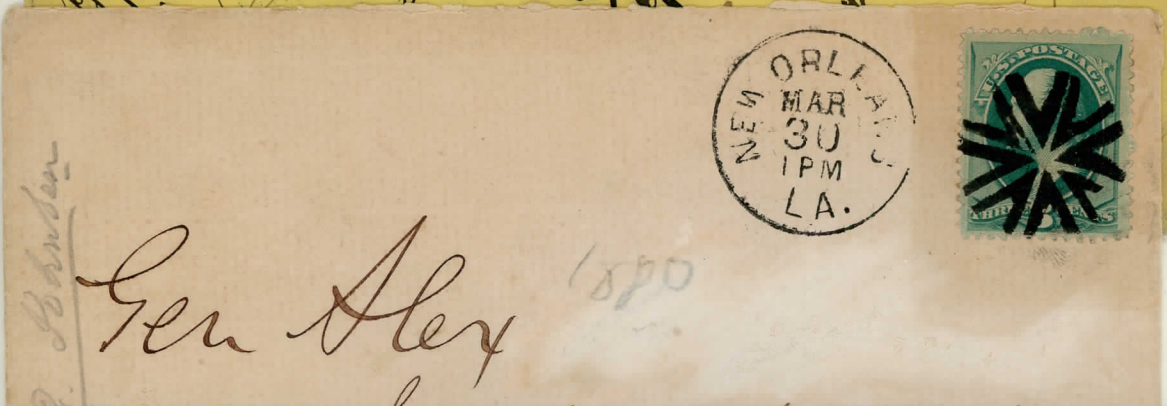


Fig. 113—Cork killers used at New Orleans. Crossro
